INVITATION TO BID FOR *PROCUREMENT OF VARIOUS DRUGS AND MEDICINES FOR THE MONTH OF MAY CY2022*

1. The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO* through the General Appropriation Act of Fiscal Year 2022 intends to apply the sum of *TWELVE MILLION FOUR HUNDRED EIGHTY-SEVEN THOUSAND FOUR HUNDRED TEN PESOS AND NINETY-EIGHT CENTAVOS (Php12,487,410.98)* being the ABC to payments under the contract for *Procurement of Various Drugs and Medicines for the month of May CY2022 with contract I.D. Nos: DM 2022-05-001*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO* through the General Appropriation Act of Fiscal Year 2022 intends to apply the sum of *TWELVE MILLION FOUR HUNDRED EIGHTY-SEVEN THOUSAND FOUR HUNDRED TEN PESOS AND NINETY-EIGHT CENTAVOS (Php12,487,410.98)* being the ABC to payments under the contract for *Procurement of Various Drugs and Medicines for the month of May CY2022 with contract I.D. Nos: DM 2022-05-001* in one (1) lot, for the *Procurement of Various Drugs and Medicines for the month of May CY2022 with contract I.D. Nos: DM 2022-05-001* being the ABC to payments under the contract for one lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO* now invites bids for the above Procurement Project. Delivery of the Goods is required ***within fifteen (15) Calendar Days upon receipt of the Notice to Proceed***. Bidders should have completed within **TWO (2) YEARS** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country

the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO* and inspect the Bidding Documents at the address given below during *office hours from 8:00 A.M. to 5:00 P.M.*

A complete set of Bidding Documents may be acquired by interested Bidders on *April 4 to 26, 2022* from the given address and website(s) below *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO* 86 BLBC Bldg., Congressional Avenue, Project 8, Bahay Toro, Quezon City or at official website: ncr.bjmp.gov.ph and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (P25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees *if it will be presented in person, by facsimile, or through electronic means.*
6. The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO* will hold a Pre-Bid Conference¹ on *April 12, 2022 at 3:00 P.M.* at *BJMP-NCRO Conference Room 86 BLBC Bldg. Congressional Avenue, Project 8, Bahay Toro, Quezon City* and/or through video conferencing or webcasting *through ZOOM application technology to be used*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *3:00 P.M April 26, 2022.* Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on *April 26, 2022 at exactly 3:00 PM* at the given address below *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO Conference Room, 86 BLBC Bldg., Congressional, Project 8, Bahay Toro, Quezon City.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity or through Zoom Video Conferencing.

The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders
