The BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO through the General Appropriation Act of Fiscal Year 2022 intends to apply the sum of TWELVE MILLION FOUR HUNDRED NINETY-FOUR THOUSAND SEVEN HUNDRED FIFTY-SEVEN PESOS AND FIFTY CENTAVOS (Php12,494,757.50) being the ABC to payments under the contract for Procurement of Various Drugs and Medicines for the month of July CY2022 with contract I.D. Nos: DM 2022-07-001. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO through the General Appropriation Act of Fiscal Year 2022 intends to apply the sum of TWELVE MILLION FOUR HUNDRED NINETY-FOUR THOUSAND SEVEN HUNDRED FIFTY-SEVEN PESOS AND FIFTY CENTAVOS (Php12,494,757.50) in one (1) lot, for the Procurement of Various Drugs and Medicines for the month of July CY2022 with contract I.D. Nos: DM 2022-07-001 being the ABC to payments under the contract for one lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The BUREAU OF JAIL MANAGEMENT AND PENOLOGY –NCRO now invites bids for the above Procurement Project. Delivery of the Goods is required within fifteen (15) Calendar Days upon receipt of the Notice to Proceed. Bidders should have completed within TWO (2) YEARS from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9.
